## Board Meeting –June 10, 2021

### Minutes

**Meeting** - President Sue LeBlanc-Durocher called the meeting to order and asked if there were any corrections to the May 13<sup>th</sup> meeting minutes. On a motion by Eric McDowell and seconded by Jeff Prescott, the May meeting minutes were approved. All voted in favor.

Treasurer's Report – Jessica Kline reported that our financials are doing fine. The money from the recent tag sale will show up in next month's financial report. We are currently ahead of where we were at this time last year. The \$655 raised from our recent pizza class will be going to the Food Shelf. We don't know how much Noon Rotary raised for this shared fundraiser. On motion by Roger Black and second provided by Jeff Prescott, the Treasurer's Report was approved.

Question was asked if our club received credit for participating in the Polio Plus Concert. We will check with District Rotary.

Jessica is working on next year's budget. She will need to know who the sponsors are for Mayor's Cup. Eric reported that UFirst is in at \$500. The draft budget was approved on a motion by Jeff Prescott and seconded by Eric McDowell. This budget will be presented to membership.

As of June 30<sup>th</sup>, Jessica will be resigning as Treasurer. Michelle Kalil has offered to replace Jessica. On a motion by Roger Black and seconded by Eric McDowell, Michelle was approved as Treasurer. Jessica will act as the back-up Treasurer.

Jessica reported that WAVE is working fine. The only issue is that we won't have year-to-year data.

**Environmental Focus** – Sunrise Rotary cleaned up Samuel D. Champlain Park for Earth Day. We had planned to also clean up Lapierre Lane but the Town of Plattsburgh crew already cleaned it up. Board thanked PM Leary for donating a portapotty for Lapierre Lane.

Membership – The Membership Committee met on May 27<sup>th</sup>. Committee members have been reaching out to past members to see if they would be interested in coming back to Rotary. The Membership Committee recommends that the following members be considered for deactivation – Rebecca King and Amel Varga. Fred Woodward was also mentioned to be deactivated. He is a 20 year member and hasn't paid dues for the current year. The committee also recommends re-activating P.J. Whitbeck. On a motion by Jim Snook and seconded by Eric McDowell, Rebecca and Amel will be deactivated and P.J. Whitbeck's membership was reactivated. Thom Loreman, Jr.'s attendance has been poor but he may attend more often once we go back to in-person meetings. The committee is also working on recruiting new members.

We will have to paid them \$150 per meeting so will need to have 13 paid members per week. For those members who aren't comfortable attending in person, the Zoom option will still be available.
