Board Meeting – January 13, 2021

Minutes

Present: Jeff Prescott; Jessica Kline; Jim Snook; Michelle Senecal; Kathy Snow; Sue LeBlanc Durocher; Tom Defayette; Roger Black; Eric McDowell; Nicole Buck

Meeting - President Prescott called the meeting to order and asked if there were any corrections to the December meeting minutes. Sue LeBlanc Durocher noted two changes: 1) Nicole Buck also attended the meeting with the Mayor and 2) those members who signed up but didn't attend the holiday dinner did pay. With these changes, the December minutes were approved on a motion by James Snook and seconded by Sue LeBlanc Durocher. All voted in favor.

Treasurer's Report – Jessica Kline reported that we are up by \$150.80 in MHAB breakfast expense. Three members still haven't paid their dues: Allison Hulbert-Bruce, MacKenzie Dumas, and Bruce Grindle.

Membership – Maxine Perry did pay the second half of her dues so she won't be deactivated. Membership Committee will meet on January 18 at 12 Noon. Committee will be reaching out to Cara Teeple. Cara is a local realtor who has expressed an interest in joining Rotary; Colleen Downs is her sponsor.

Small Contributions Committee – Kathy Snow reported that a \$500 check will be mailed to 100 Margaret Street (mental health awareness organization) to purchase a tent for outside activities. A \$500 check will also be sent to Catholic Charities to purchase gas card for community members struggling with paying for gas to get to work.

Attendance – Roger Black reported concern about MacKenzie Dumas' and Tom Loreman Jr.'s attendance. MacKenzie has recently changed jobs; Sue will reach out to her. Concern was also expressed about Nikki Buck's attendance as she is in line to become President for the 2023/2024 year. Sue has been in touch with Nikki and she has recently returned to work and is finding challenges with that and being a new mom.

Mayor's Cup 2021 – Sue shared that the Mayor's Cup Committee met last week and a decision was made to have CV Tech Design students create our Mayor's Cup logo. The band, Damaged Goods, are in again this year. Mayor's Cup Committee will meet the second Monday of the month.

Zoom Meetings – President Prescott and Colleen Downs met to discuss some ideas to make our weekly Zoom meetings more interactive and fun. Some of the ideas include trivia and breakout rooms ... more details to come.

Annual Meeting & Election of Officers – Jim Snook will send out the slate of officers to membership so we can vote on it at our next meeting.

501c(4) vs. 501c(3) – Sunrise Rotary is a 501c(4) which is the designation for humanitarian organizations. If we were a 501c(3) we would be a charitable organization and would be able to apply for grants. Jessica checked with a CPA to see what is involved in switching. CPA suggested that we contact an attorney as it isn't an easy switch. More research will be done.

Bi-Weekly Meeting Format – More discussion needs to be held on our meeting format. Nikki will get Jeff a survey to send to membership. Bylaws will also need to be looked at.

Fellowship – Sue reported that there isn't anything currently scheduled.

(2-a) the purpose or purposes for which it is formed, it being sufficient to state that the purpose of the corporation is any purpose for which corporations may be organized under this chapter as a charitable or non-charitable corporation, and whether it is a charitable corporation or a non-charitable corporation under section 201 (Purposes). Any corporation may also set forth any activities that it intends to carry out in furtherance of such purpose or purposes; provided that this subparagraph shall not be interpreted to require that the certificate of incorporation set forth such activities or otherwise

state how the corporation's purposes will be achieved.

I highly suspect—that if you look at your incorporation documents- the second paragraph will say you were not formed as Charitable.

So no 501 c 3.

Sunrise Rotary could always form a separate Corp- with purely charitable purposes- Separate books, etc etc.

Then still have to get IRS 1023 Form recognition- and then NY Attorney General Recognition
