Minutes

Present: Roger Black, Jessica Kline, Jeff Prescott, Sue LeBlanc-Durocher, Eric McDowell, Jim Snook

Meeting Minutes

President Sue LeBlanc-Durocher called the meeting to order at 7:32 am and asked if there were any change/corrections to the November Board meeting minutes. On a motion by Roger Black and seconded by Eric McDowell, the November meeting minutes were approved. All voted in favor.

Club Goals

We must have goals setup in RI for the club. Sue has done this for the 2020-2021 year. This should be done for the 2021-2022 year. Sue would like to set a date in January to work on this and become familiar with the site. We should assess the health of our club as our membership has declined in the last few years. We should have backup in place for various positions in the club.

Treasurer's Report

Jessica presented the Treasure's report. As of the end of November we have a profit of \$3749. Member donations through November are \$1059.05 compared to \$301 last year. We are doing a good job keeping expenses down.

Jessica discussed the benefits of having the additional insurance policy through Philadelphia. This was put in place to insure the club against external theft back when we raised much more money at our events. The board discussed and felt that the policy through RI is appropriate for our current activities and we no longer need the additional policy. Motion to cancel the additional Philadelphia policy was made by Jeff Prescott, seconded by James Snook. All voted in favor. Jessica will contact Randy Giltz to discuss cancellation.

Jeff Prescott requested the word donations be added to the description on account 4040 in the general ledger. Jessica will make that change.

Sue Leblanc-Durocher will contact Faith Long from the Noon Club about the Roteract Polio Donation that was not received by our club.

Motion to approve the treasurers report was made by Roger Black, seconded by Eric McDowell. All voted in favor.

Membership

Nikki Buck is out on leave of absence awaiting the birth of their baby. Roger Black has her listed on LOA in Clubrunner.

There will not be a membership committee meeting in December. Jeff will try to get the January committee meeting scheduled on January 7, 2021. Sue Leblanc-Durocher asked who was part of the membership committee. Jeff Prescott listed off who he currently has listed as members. Jeff Prescott will update the committee member roles.

Rebecca King has been ill for much of the year and Sue Leblanc-Durocher has not heard from her since her email in October. Roger Black has her listed as leave of absence. We will reach out to her again in a few months.

Debra Stevenson has had to end her membership due to a change in her employer. She spoke with Sue Leblanc-Durocher last week about leaving the club. Her current work schedule will not allow her to attend. Eric McDowell had also reached out to her when he received the email that she did not receive her raffle tickets. Roger Black suggested we discuss new members leaving the club sometime in January maybe at club assembly.

Same members still have not paid their membership dues. Jessica emailed statements again on Monday 12/7.

Raffle Ticket Sales

Net Revenue after prize payout was \$2890 for the club. Kathy Snow sold 21 tickets. Maxine Perry sold 20 tickets. Only 7 members did not sell any tickets. Eric McDowell thinks we need to come up with a different idea or sell the tickets at a different time of the year.

He finds this discouraging. He was trying to engage the new members. Roger is willing to still work on this and try to get something going. Sue Leblanc-Durocher suggested he resend the email and copy a few of the board members in hopes that he will get some responses.

Fundraising

Sue Leblanc-Durocher will bring up fundraising at the club assembly. We should try to get some ideas together for different fundraisers to keep our finances in the black.

Attendance
